Rules and Conditions of Entry:

Definition of All Aged Stake: A stake which is open to all dogs of a specified breed or breeds without restriction to their age, but which may be restricted by any other conditions which may be determined by the Society subject to the approval of the General Committee of the Kennel Club.

Preference in the Draw will be given in the following order:- (1) Members Dogs with any award in a Field Trial, (2) Any other Members Dog, (3) Any non-Members Dog. Club Rules & Regs 12.ii. Substitution will only be allowed at the FT Secretary's discretion
